YOUR RESPONSIBILITY

Once you are registered, you have a legal requirement to notify the Board of any changes to your residential, postal or work address within one month of the change. You can do this by logging into "My Profile" on the website.

BOARD'S RESPONSIBILITY

The primary responsibility of the Board is to protect the health and safety of the New Zealand public by ensuring practitioners registered with the Board are competent and fit to practise.

APC renewals

The renewal process for your 2022/2023 APC opened on 16 February 2022 and remains open until COB 31 March 2022.

RESETTING YOUR PASSWORD:

If you have forgotten your password, you can use the "Forgotten Password" option to reset it. There are two ways you can reset your password:

- via the email address registered with the Board and we will send you a link to reset you password; or
- via text message.

If you have forgotten your password and you do not have access to the email address registered with the Board and/or your mobile number is not up to date, email the Board's staff at mrt@medsci.co.nz and they will update your details.

COVID-19 Vaccination Order

Please note that under the ministerial COVID-19 Vaccination Order, all healthcare practitioners were required to have a booster by 11:59pm Thursday 24 February 2022, if eligible.

As registered health practitioners under the Act, this includes all medical imaging and radiation therapy practitioners. For more information please see the Ministry of Health's website.

Overseas-Trained Registrations

With the imminent opening of the New Zealand border, the Board looks forward to assisting those practitioners who meet the eligibility requirements of registration to be able to gain an Annual Practising Certificate and join the medical imaging and radiation therapy workforce.

Provisional Vaccinator Course

The 2022 provisional vaccinator course run by IMAC is now open. Provisional vaccinators can administer MMR and influenza vaccines. If you wish to also administer the Paediatric Pfizer vaccine or AstraZeneca vaccine, you must complete the appropriate COVID-19 vaccinator education course. Accessing the course

To access the course, you will need to provide a code from your employer or provider you intend to work for. Please do not contact IMAC directly. Any questions about access or eligibility can be directed to the IMAC education team at imacetadmin@auckland.ac.nz.

Critical Work - Omicron outbreak

In lieu of the ever-changing Omicron outbreak, Medical Sciences Secretariat advises that in the instance of the majority of its staff being sick with COVID-19, only critical work will be completed. Critical work has been identified as the following:

The registration team's priorities will be:

- APC renewals
- New Zealand registration
- Matters relating to the government's COVID health response e.g., interim APCs for the COVID surge workforce.
- Risk assessment for any new professional standard cases
- Responding to queries during the period that only critical work is completed, email communication will be the preferred method of contact and will take precedence over phone calls.

Overseas registration applicants with a current job offer and who can provide evidence of meeting immigration requirements into New Zealand will be prioritised over all other overseas registration applications.

Communication priorities:

Updating the website on any regulation or Ministry of Health communiques.

During the 'red light' setting in the COVID Protection Framework, all staff will be working from home and the office is now closed until further notice.
